

# 89 organizations responded

**Significant disruptions continue to affect operations and revenue throughout the nonprofit sector.** Understanding how the COVID-19 pandemic affects the operations of local human service nonprofits is an important step in determining where support is needed most.

United Way of Central Ohio and Human Service Chamber of Franklin County have now partnered with Illuminology to continue surveying the local nonprofit community.

The results of our second survey are included in this report and capture the work of nonprofit organizations that together offer nearly 1,000 programs.

# Survey dates: April 3-7, 2020

Within the first month of the COVID-19 pandemic, only 20% of nonprofit programs are operating as they did before the crisis. Many local nonprofits have eliminated a significant part of their workforce due to COVID-19. Lost revenue from cancelled fundraising events is estimated to be over \$8 million, among other revenue impacts.

Results like these will be shared with public officials, stakeholders, donors and other decision-makers to provide important data about the safety net for vulnerable people as it continues to suffer significant setbacks.

Additional surveys are planned to track how needs may change and expand. More results follow.




# **IMPACT ON REVENUES**

83%

Nearly all Central Ohio health and human service nonprofits experienced revenue loss due to the COVID-19 crisis.

Most nonprofits report losing revenue from multiple sources due to the COVID-19 crisis.




# **IMPACT ON SERVICE DELIVERY**



#### **TECHNOLOGY NEEDS: HARDWARE**



#### **SBA LOAN APPLICATIONS**

At the time of the survey, most health and human service nonprofits in Central Ohio had decided to apply for an SBA loan via the CARES Act. About a guarter weren't certain if their nonprofit would apply for this funding.
